AACLA Purpose

The purpose of this report is to document the Fiscal Year 2016 activities and accomplishments of the AACLA for donors and volunteers. This is a yearly summary report and additional details can be obtained by contacting one of the officers. The AACLA was incorporated in the State of Iowa on January 3, 2014 and became a 501(c)(3) non-profit organization in October 2014.

The purpose of the AACLA is to preserve, honor, and interpret the legacy and memory of Arthur A. Collins and the significant contributions he and Collins Radio Co. made in the world of communications, aerospace and defense technologies. The AACLA is organized for the purpose of promoting education in Science, Technology, Engineering, and Mathematics (STEM). The organization works to inspire and teach future generations by the preservation and display of artifacts, conducting educational events, exploring grants and other funding opportunities which may ultimately lead to the creation and operation of a heritage learning center in Cedar Rapids, Iowa.

AACLA Projects

AACLA Projects fall into six broad categories. A summary of Fiscal Year 2016 activities of each follows:

1. Collins Historical Documentaries

- Initiated discussions with Iowa Public TV about producing & airing a 1 to 2 hour documentary on Arthur A. Collins and the Collins Radio Company
- Conducted video interviews with 12 individuals at Methwick Manor
- Plan for video interviews with retirees in the Dallas, TX area
- Plan for production of additional short documentaries
- Continued sales and promotion of the DVD "*The Arthur Collins Legacy - A Culture of Innovation*"

2. AACLA Publications

- Wrote a comprehensive article on Arthur A. Collins and published it on Wikipedia at: https://en.wikipedia.org/wiki/Arthur_A._Collins
- Received ownership of Ben Stearn's book "*Arthur Collins - Radio Wizard*"

3. AACLA Heritage Center

4. Artifact Collection and Preservation

- Received numerous donations of Collins equipment and documents
- Created a formal policy & procedure for archiving digitized documents, data, and video media with off-site archival storage in safety deposit box in Collins Credit Union vault

5. Public Events and Presentations

- Historical artifacts and media display at Rockwell Collins Supplier Conference
- Keynote speaker at the Collins Collectors Association Banquet; Q & A with board members following showing of documentary
- Provided programs for Rockwell Collins History Community of Practice Events
- Provided DVD of "Culture of Innovation" documentary for viewing by Dallas Collins Retiree Association (approximately 200 members)

6. AACLA Development (Funding)

- A designated board member leading effort of writing grant proposals
- Two grant proposals submitted

Fiscal Year 2016 Financial Report

The AACLA received revenue of \$10,083 and incurred expenses of \$17,541 for its Fiscal Year that ended September 30, 2016 for a net loss of \$7,458. This Fiscal Year 2016 loss was driven by expenditures of \$8,612 during the first three months of the year for expenses to complete the documentary "***A Culture of Innovation***" and the start of interviews in support of AACLA's next documentary production. This expenditure was paid for with protected documentary funds received by AACLA during its Fiscal Year 2015. Therefore, \$1,154 was realized after adjusting for the use of the protected funds. The AACLA is starting its Fiscal Year 2017 with much less cash than is needed to support planned projects, its next documentary, and budgeted operating expenses.
